

**Food Waste Source Separation, Collection and Delivery to  
Organic Resources Recovery Centre Phase 1 - ORRC1 (also known as O·PARK1)**

**Invitation for Expression of Interest**

**Purpose**

1. This note is addressed to major food waste producers of the commercial and industrial (C&I) sectors. It seeks their expression of interest (EOI) (non-binding) on implementing food waste source separation, collection and delivery to Organic Resources Recovery Centre Phase 1 (O·PARK1) and indicating the need of technical support from the Government.

**Background**

2. In February 2014, the Government published “A Food Waste & Yard Waste Plan for Hong Kong 2014-2022” (the Plan) which maps out four strategies to tackle food waste, namely reduction at source, reuse and donation, recyclable collection, and turning food waste into energy.

3. The O·PARK1 at Siu Ho Wan, North Lantau, is a key project under the Plan. It has started intake food waste from the C&I sectors since July 2018 and is now ready to convert 200 tonnes per day of food waste to biogas as renewable energy as well as compost for agricultural use.

4. Support from the C&I establishments in source separation and delivery of adequate food waste to O·PARK1 is crucial to the effective operation of the O·PARK1. A number of C&I sectors, including shopping malls, hotels, food factories and chain restaurants etc., have indicated their support and commitment to deliver their source separated food waste to the O·PARK1, which helps divert food waste from landfills. To provide support and facilitation on this worthwhile initiative, we have engaged service contractor to provide the line management as well as frontline staff of all committed C&I establishments with technical support, on how to separate food waste at source, as well as on collection and transportation logistics through briefings/ trainings and site visits.

**Benefits of Early Indication of the Expression of Interest**

5. To better utilize the limited treatment capacity of the O·PARK1, a quota allocation system will be set up in order to distribute the operational capacity of the O·PARK1 in an open, fair and transparent manner when the demand of delivery exceeds its design capacity. Therefore, C&I establishments who have an early indication of their interest could enjoy the following benefits –

- (a) an early participation would help the C&I establishments to secure a proper outlet of their food waste well in advance of the rollout of the municipal solid waste (MSW) charging scheme so as to avoid any last minute rush, or the risk of not being able to secure any quota due to the limited capacity of the O·PARK1;
- (b) one of the criteria in assessing food waste producers' applications for quota allocation is past performance and track record. Hence, the C&I establishments which have joined the food waste recycling at the O·PARK1 earlier and have consistently given satisfactory performance would enjoy some advantage over the new comers;
- (c) in the long run, subject to the level of MSW charges, C&I establishments in the O·PARK1 catchment would potentially save MSW charges on the food waste portion generated as well as some transportation cost by delivering the source separated food waste to the O·PARK1;
- (d) the C&I establishments could have a better plan on their operation by taking into account the need for source separation and collection of food waste through early negotiation with a list of potential food waste collectors. Hence, the C&I establishments can make necessary arrangements that dovetail with the operation of the facility in a timely manner;
- (e) carbon emission reduction certificate would be awarded to participating companies for official publications in the sustainability/ annual reports; and
- (f) this would also enhance C&I establishments' environmental friendly image and in turn attract more environmentally conscious customers.
